Descendants of Willem Brouwer & Rebecca Vedder For two generations

Generation One

1. **WILLEM**¹ **BROUWER** was born in 1668/69 <u>if</u> he is a son of Willem Brouwer and Lysbeth Drinckvelt, <u>if not</u> a son then more likely born around 1690. He married **Rebecca Vedder**, daughter of **Arent Vedder** and **Sara Groot**, Schenectady, New York, circa 1711. He died between 10 Feb 1757 and 15 Feb 1765 Stone Arabia, (then Albany Co.), New York; (dates of will and proving).

Also known as **William Brower**.² He was first at Schenectady and later was an early settler at Stone Arabia, on the north side of the Mohawk River. He witnessed the baptism of **Daniel de Graaf**, son of **Jesse de Graaf** and **Aaltje Akkermans**, on 26 May 1709 First Reformed Church, Schenectady, New York, (sponsors Willem Brouwer, Anna Akkermans).³ On 1 Sep 1734 William Brouwer of "Schonaghton" (Schenectady) in the County of Albany, Provence of New York, yeoman, received through a quit-claim deed from Barhanardus Van Diere of Bergen County, New Jersey, and a long list of men (most of who were from the German Palatinate; see footnote) from Albany County, New York, lotts of wood land situate lying and being in the Mohawk Country about three miles into the woods on the north side of the River and is known by the name of Stone Rabpie (Stone Arabia), in the County of Albany (numbers 11, 82, and 84). Many of the men signed with their mark.⁴ On 10 Dec 1739 Hendreck Schremling of Conojoharry in the County of Albany, yeoman, for one hundred and twenty pounds, conveyed to William Brower of the same County, yeoman, six lots of land which he had from Jackob Schnell, Mardem Dillebag and Henreck Wallerath, the lots of land situate, lying and being at Stonerabie (Stone Arabia) on the north side of the Mohawks River, lot nos. 17, 19, 21, 79, 82 and 84. Witnesses by Hendreck Frey, Brynant C. Zondenbargh, Harmen F. Vescher.⁵ William Brower was an executor for the estate of his father-in-law, Arent

Vedder, as named in his will dated 10 Aug 1746.⁶ He witnessed the baptism of **Willem Brouwer Visscher**, son of **Harman Frederickse Visscher** and **Catharientje Brouwer**, on 30 Apr 1749 First Reformed Church, Schenectady, New York, (sponsors Willem Brouwer, Rebecca Vedder).⁷ In 1757 **Willem Brouwer** resided Stone Arabia, (then Albany Co.), New York.⁸ His will was dated on 10 Feb 1757 William Brower of Stone Raby in the County of Albany on the Mohawks River Yeoman Being Verry well in Good helth & Sound Perfect Mind and Memory, Thanks Be Given unto God therefore, Calling unto mind the Mortality of my Body, and Knowing that it is appointed for all memories to Die Do therefore make and ordain this my Last Uncontroled Will and Testament...

To oldest son Arent Brower his Exrs or Administrators the Just and full Sum of Ten Pounds Currant Lawfull money of New York To be paid out of my Estate for his Premogeniture...

To my loving wife Rebeka Brower, all and Singuler my Real and Personal Estate during her Widdowhood...

and immediately after ____ wife Rebecka Decease if She Remain Unmarried or Immediately after her Remarriage I do then Give Devise & Dispose of the Same In Manner & forme Following (to wit) To my sons Arent Brower and Harmen Brower and to their Heirs...three lotts of Land Called No. Seventeen, No. Noneteen & No. Twenty one contatining Eacg Fifty Acres which is together One Hundred & fifty acres Suticated Lying and Being on the North side of the Mohawks at a Place Called Stone Rabie within the County of Albany within the bounds of the Stone Rabie Patten whereon I now live or Dwell, to be shared & Divided in manner and form follwing...

To be paid unto my five daughters (to wit) Sarah Brower, Catriena The wife of Harmen F. Visger (later Fisger), Angenietje, the wife of Ephraim Wempel, Elizabeth Brower and Maria Brower or to their Exds admd or asigns The Just and full Sums of Five Hundred pounds Current Lawfull of the Province of New York...

To son Arent, my large iron kettle and negroman named Thom. All farming tools, waggons, sleads, plow & harrow, and all cattle, horses, mares, colts, sheep, hoggs, cows, heffers, steers, calfs, etc. to my sons Arent Brower & Harmen Brower. Hosuehold good and furniture to daughters, equally. Shear and Shear alike.

All money Due to me by Bills Notes Bonds, Book Debts, to my two sons, Arent Brower & Harmen Brower.

Appoints as executors, my loving Friend John Sanders And my Brother In Law Albert Vedder.

Signed by his mark. Witnesses: Jacob Glen (mark), Isaac F T Truax (mark), and Andries Finck.

Proved 15 Feb 1765, before the Surrogate of Albany County, Jno. DePeyster, by Isaac Truax and Andries Finck. Arendt Brower, in his will dated 10 July 1793, names his father William "deceased." It must be emphasized that the placement of William Brower of Stone Arabia as a son of Willem Brouwer of Beverwijck is, at best, speculative. The placement seems to be based upon tradition apparently begun with Jonathan Pearson in 1873 and continued to this day. Pearson's reasoning may be solely influenced by the fact that the two share a common name and that William Brower (the younger) appears first in Schenectady, as do other children of Willem Brouwer (the elder). If Pearson knew of any other evidence to support this placement, he apparently never published or expalined it. To date, I can find no evidence that would meet modern standards of genealogical research, that would indicate that William Brouwer of Beverwijck, and Willem Brower of Stone Arabia, are father and son.

The placement here of William Brower as a son of Willem Brouwer is characterized as "Claimed."

REBECCA VEDDER was baptized on 25 Oct 1691 Reformed Dutch Church, Albany, New York; sponsors Philip Foreest, Rebecca Groot.¹¹ She witnessed the baptism of **Willem Brouwer Visscher**, son of **Harman Frederickse Visscher** and **Catharientje Brouwer**, on 30 Apr 1749 First Reformed Church, Schenectady, New York, (sponsors Willem Brouwer, Rebecca Vedder).¹² She named in her husband's will on 10 Feb 1757.¹³

Children of Willem¹ Brouwer and Rebecca Vedder were as follows:

- Johannes² BROUWER was baptized on 21 Jun 1712 First Reformed Church, Schenectady, New York; sponsors Claes Fransz and Sara Groot.¹⁴ He died before 10 Feb 1757; (not mentioned in his father's will).¹⁵
- 3 ii. Sara BROUWER was baptized on 4 Dec 1715 First Reformed Church, Schenectady, New York; sponsors Arent Vedder, Annetian Vedder. She probably died before 10 Jul 1793 as she is not named inher brother Arndt Brower's will, while other siblings are.

Also known as **SARAH BROWER.**¹⁷ She witnessed the baptism of Petrus Luis, son of Peter Luis and Lena (____), on 7 Mar 1756 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Arendt, Wilhelm Brauers lediger Sohn (William Brower's single son), Sara Braurin). She witnessed the baptism of Wilhelmus Brouwer, son of Harmanus Brouwer and Margariet Ekker, on 9 Dec 1756 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Sartie Brouwer, Arend Brouwer). She was named in her father's will dated on 10 Feb 1757 daughter, "Sarah Brower." She witnessed the baptism of Sara Wemple, daughter of Ephraim Wemple and Angentia Brouwer, on 25 Feb 1760 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Arent Brower, Sarah Brower).

4 iii. Arent BROUWER was baptized on 29 Mar 1718 First Reformed Church, Schenectady, New York; sponsors Jesse de Graaf, Aeltie de Graaf.²² He died on 20 Jul 1793 Stone Arabia, Montgomery Co., New York; age 74y 4m 8d.²³

Also known as **AARON BROWER.**²⁴ He witnessed the baptism of Petrus Luis, son of Peter Luis and Lena (), on 7 Mar 1756 Reformed Dutch Church of Stone Arabia. Town of Palatine. (now Montgomery Co.), New York, (sponsors Arendt, Wilhelm Brauers lediger Sohn (William Brower's single son). Sara Braurin).²⁵ He witnessed the baptism of Wilhelmus Brouwer, son of Harmanus Brouwer and Margariet Ekker, on 9 Dec 1756 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Sartie Brouwer, Arend Brouwer).²⁶ He was named in his father's will dated on 10 Feb 1757 referred to as oldest son.²⁷ He witnessed the baptism of Sara Wemple, daughter of Ephraim Wemple and Angentia Brouwer, on 25 Feb 1760 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Arent Brower, Sarah Brower).²⁸ He witnessed the baptism of Elizabeth Wemple, daughter of Ephraim Wemple and Angentia Brouwer, on 11 Dec 1772 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Aron Brower, Elizabeth Brower).²⁹ He witnessed the baptism of William Brower Garrison, son of Abraham Garrison and Maria Brouwer, on 4 Apr 1774 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Arent Brower, Rebecca Wemple), 30 He witnessed the baptism of Angenitje Vedder, daughter of Aarnhoudt Vedder and Ariaantje Wemple, on 30 Apr 1775 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Arent Brower, Rebecca Wemple).³¹ On 2 Jun 1775 Arent Brower of Stone Rabie (Stone Arabia) on the Mohawks River in the County of Tryon, New York, yeoman, of the first part, and Harmen Brower, of the same place, yeoman, of the second part, partitioned various lots of woodland formelry possessed by William Brower of Stone Raby in the County of Tryon, late deceased father of the said Arent Brower and Harmen Brower.³² He witnessed the baptism of Arent Smith, son of Aaton Smith and Catrina Veling, on 6 Dec 1778 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Aaron Brower, Elizabeth Brower), 33 He witnessed the baptism of Harmen Visscher, son of Frederic Visscher and Gesina de Graaf, on 26 Apr 1780 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Aaron Brouwer, Catrina Fisher).³⁴ Arent apparently never married and left no heirs. His will mentions his siblings, nephews and nieces, and is an important document in placing together this extended Brower family. His will was dated on 10 Jul 1793 proved 13 Nov 1793. called Arndt Brower of Stone Arabia, mentions his brother Harmen, and his (Harmen's) children John, Wilhelmus, Arndt, Harmon, Cornelius, Rebecka, Deborah, and Sarah wife of Doxstedder; sister Elizabeth; sister Maria's daughters Margareth Hanson, Maria Newkirk and Rebecca and Nancy Putman; sister Anenetche Wemple's daughters Rebecca and Sarah; sister Maria's son William Brower Garrison; father William deceased; Arendt A. Vedder; Anenetche Doxstedder: Harmon Visscher, son of Fred; the will mentions money due from manager for building the new Reformed Protestant Dutch Church at Stone Arabia. Executors: nephews Arndt

- + 5 iv. Catharientje BROUWER was baptized on 11 Sep 1720 First Reformed Church, Schenectady, New York. She married **Harman Frederickse Visscher**, son of **Frederick Harmense Visscher** and **Margareta Hanse**, circa 1739. She died on 22 Jan 1791.
- + 6 v. Harmanus BROUWER was baptized on 6 Jan 1723 First Reformed Church, Schenectady, New York. He married Margariet Ekker, daughter of Jan Ekker and Margrietje Vile, First Reformed Church, Schenectady, New York, on 8 Feb 1755 "Harmen Brouwer and Margrita Ecker of Schdy." He died in 1803.

Elisabeth BROUWER was baptized on 3 Jan 1731 First Reformed Church, Schenectady, New York; sponsors Pieter Brouwer, Elizabeth Brouwer.³⁸ She died on 21 Feb 1815; "ae. 87 yrs, 3 mos.," apparently never married.³⁹ She was possibly buried Newkirk Graveyard, near Rees Farm, near Fort Hunter, Montgomery Co., New York.⁴⁰

Also known as **ELIZABETH BROWER.**⁴¹ She witnessed the baptism of John Joost Finck, son of Andries Finck and Catharina Laux, on 4 Aug 1753 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Diderich Laux Junior, Elisabeth Brouwer).⁴² She was named in her father's will dated on 10 Feb 1757 daughter, "Elizabeth Brower."⁴³ She witnessed the baptism of Rebecca Garrison, daughter of Abraham Garrison and Maria Brouwer, on 18 Mar 1764 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Elisabeth Brower und Aarerndt Futter beyde ledig).⁴⁴ She witnessed the baptism of Harmen Brouwer, son of Harmanus Brouwer and Margariet Ekker, on 28 Aug 1768 Reformed Dutch Church of Stone Arabia, Town of Palatine, (now Montgomery Co.), New York, (sponsors Johannes Fischer und Elisabeth Brawer).⁴⁵ She witnessed the baptism of Elizabeth Wemple, daughter of Ephraim Wemple and Angentia Brouwer, on 11 Dec 1772 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Aron Brower, Elizabeth Brower).⁴⁶ She witnessed the baptism of Arent Smith, son of Aaton Smith and Catrina Veling, on 6 Dec 1778 Reformed Church, Caughnawaga

Also known as **Agnes Brewer** (called Agnes [Brewer] Wemple in the Trinity Church baptism records of daughters Arriantje and Rebecca).²⁶¹ Also known as **Anenetche**.²⁶² A record of birth or baptism has not been found. She is called "sister Anenetche Wemple" in the will of Arndt Brower, dated 10 Jul 1793.²⁶³ She witnessed the baptism of **Margrietje Visscher**, daughter of **Harman Frederickse Visscher** and **Catharientje Brouwer**, on 30 Sep 1747 First Reformed Church, Schenectady, New York, (sponsors Harmen Joh. Fisher, Agnietje Brouwer).²⁶⁴ **Angentia Brouwer** and **Ephraim Wemple** resided near Fort Hunter, Montgomery Co., New York.²⁶⁵ She was named in her father's will dated on 10 Feb 1757 daughter, "Angenietje, the wife of Ephraim Wempel."²⁶⁶ She witnessed the baptism of **Claas Wemple**, son of **Charles Wemple** and **Susanna Primus**, on 12 Sep 1761 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Epraim Wimp, Anganietie Wimp).²⁶⁷ She witnessed the baptism of **Sara Brouwer**, daughter of **Harmanus Brouwer** and **Margariet Ekker**, on 7 Jul 1772 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Ephraim Wemple, Angenietche Wemple).^{268,269} Her will was dated on 3 Sep 1804.²⁷⁰

EPHRAIM WEMPLE was baptized on 16 Feb 1724.²⁷¹ Also known as **Ephraim Wimp** (some Dutch Church records).²⁷² He witnessed the baptism of **Claas Wemple**, son of **Charles Wemple** and **Susanna Primus**, on 12 Sep 1761 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Epraim Wimp, Anganietie Wimp).²⁷³ He witnessed the baptism of **Sara Brouwer**, daughter of **Harmanus Brouwer** and **Margariet Ekker**, on 7 Jul 1772 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Ephraim Wemple, Angenietche Wemple).^{274,275} He served in the Revolution in Col. Fisher's Regt.²⁷⁶

Children of Angentia² Brouwer and Ephraim Wemple were as follows:

i. Ariaantje³ WEMPLE was baptized on 27 Oct 1751 Mohawks (Trinity Church Parish record).²⁷⁷ She married Aarnhoudt Vedder on 27 May 1768.²⁷⁸

- ii. Rebecca WEMPLE was baptized on 12 Aug 1753 Mohawks (Trinity Church Parish record).²⁸⁰
 She witnessed the baptism of Angenitje Vedder, daughter of Aarnhoudt Vedder and Ariaantje Wemple, on 30 Apr 1775 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York, (sponsors Arent Brower, Rebecca Wemple).²⁸¹ Rebecca, daughter of sister Anenetche Wemple, is named in her uncle Arndt Brower's will dated 10 July 1793.²⁸²

Johannes WEMPLE was baptized on 23 May 1756 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York; sponsors Andreas Wimp [error for Andreas Bratt], Ariaantje Wimp, and recorded, with the same date, at Schenectady but with sponsors Reyer Wempel and Debora Wempel.^{283,284} He died before Sep 1762.²⁸⁵
- iv. Debora WEMPLE was baptized on 25 Feb 1760 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York; sponsors Douwe Fonda, Debora Fonda. She married Nicholas Hansen on 2 Dec 1778. She married Nicholas Hansen on 2 Dec 1778.

Sara Wemple, daughter of sister Anenetche Wemple, is named in her uncle Arndt Brower's will dated 10 July 1793.²⁹¹

CORNELIUS WEMPLE was born by in 1756. He died in 1791.²⁹² He served during the Revolution in Col. F. Fisher's Regt.²⁹³ His will was dated on 19 Jul 1791.²⁹⁴

39 vi. William WEMPLE was baptized on 18 Aug 1762.²⁹⁵

William served during the Revolution under Col. Fisher. He was a merchant near Fort Hunter, New York, and never married.²⁹⁶ William's placement here is questioned. He is placed in this family in the Wemple Genealogy and appears in NYGBR 35:195. However, the baptism date given is only one month prior to the date of that of Johannes Wemple found at the Caughnawaga Church. William's baptism has yet to be confirmed with an original source record.

vii. John E. WEMPLE was baptized on 19 Sep 1762 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York; sponsors Andreas Wimp, Ariaantje Wimp.²⁹⁷ He married Jane Anthony, daughter of Nicholas Anthony and Susanna Roome, on 27 Mar 1796.^{298,299} He died on 25 Aug 1842.³⁰⁰

He served in Col. F. Fisher's Regt. during the Revolution, and lived near Ft. Hunter, New York.³⁰¹

JANE ANTHONY was baptized on 4 Jan 1768.³⁰² She married first on 11 Feb 1790 **Ahasuerus Turk Jr.**³⁰³ She died on 15 Jan 1853.³⁰⁴

viii. Cornelius WEMPLE was born in 1766.³⁰⁵ He married first on 19 Feb 1797 Jane Vreeland.³⁰⁶ He and Jannetje Demorest were said to have married before 1808 (*Demarest Family*) but this is contradicted by "Wemple Genealogy," *NYGBR* 35 (1904):236.³⁰⁷ He married second on 17 Sep

1816 Jane Bradt.³⁰⁸ He died between 1 Jan 1820 and 25 Mar 1820 Florida, Montgomery Co., New York; (dates of will and probate).³⁰⁹

Cornelius Wemple resided Florida, Montgomery Co., New York.³¹⁰ His will was dated on 1 Jan 1820 probated 25 Mar 1820. Cornelius Wemple of the town of Florida. Mentions: first wife, *dead*; present wife Jane; mother-in-law Caty Vreeland; sons John Vreeland, David Demarest, Ephraim and William; daughters Caty and Agnes. Executors: son William, Jacob Van Olinda. Witnesses: Jacob L. Van Olinda, Henry Peek, Abraham A. Bradt.³¹¹

JANNETJE DEMOREST was born on 26 Oct 1777.³¹² She was baptized on 16 Nov 1777 Dutch Reformed Church, Schraanlenburgh, Bergen Co., New Jersey; sponsors Jacob Brouwer, Jannitie Vanderbeek.³¹³ She married first First Reformed Church, Schenectady, New York, on 18 Jul 1793 **Cornelis Brouwer**, son of **Hendrick Brouwer** and **Maria Brouwer**.^{314,315} In 1810 U.S. Federal census: A widow Brewer is enumerated in Ward 1, Schenectady, New York, with a household of 1 male 16-25, 1 female 16-25, 2 females 26-44 and 1 female over 45.³¹⁶

- ix. Elizabeth WEMPLE was born on 22 Nov 1772. 317.318 She was baptized on 11 Dec 1772 Reformed Church, Caughnawaga (now Fonda), Montgomery Co., New York; sponsors Aron Brower, Elizabeth Brower. 319 She married John S. Ten Eyck, son of Myndert S. Ten Eyck, on 20 Jul 1799. 320
