In the first Place I Recommend my Soul into the hands of Almighty God who gave it, and my body to the earth from whence it came to be decently interred according to the Custom of our Predecessors, in hopes of a Joyful resurrection through the Alone merits of my blessed Savior and redeemer Jesus Christ. And as to the residue of my Estate both real and personal of which I have made no other disposals. I make the following Viz: I give and bequeath to my Som Wilhelmus Brower the sum of Five dollars as his right of Promogeniture. I give and bequeath and devise to my Son Harme Brower Junior the farm on which I now live with all and Singular the buildings and appurtenances thereunto belonging to hold to him his heirs and Assigns for ever. Also my Pleasure Sleigh. The rest of my farming utensils it is my will shall be equally divided Amongst my five Sons. I give and bequeath to my daughter Deborah Brower the sum of Two hundred and fifty dollars , to be paid to her by my son Harme, five years. After my decease. I also give and bequeath to my three daughters Rebecca Van Deusen, Sarah Docksteder and Deborah Brower all my household furniture six weeks after my wifes decease. I give to my beloved wife after my decease, the best room in my house ( to be left to her choice) and there to be supported with every necessary of life complete by my son Harme Brower Junr.

And I do order and direct that all my Just debts shall be paid and discharged by my Executors, who are also to collect my outstanding debts, and divide what money may remain ( after discharging my Just debts) Among my five Sons equally. And lastly I recommend to all my children, an honest and upright conduct

in all their dealings with mankind, and particularly to live in harmony And friendship with each other as brothers and Sisters agreable to the ordinances of God, for whose Peace cannot be found Grace cannot be looked for.

And I do by these Presents appoint my trusty and well beloved friends Hendrick Frey Esquire of Canajohary. Mr. Cornelius Smith of Caughnawaga, and Wilhelmus Brower my Son to be the Executors of this, this my last Will and Testament hereby reyoking all others by me heretofore made.
