This Indenture made this nineteenth day of december in the year of our lord one thousand eight hundred and eighteen between Richard Brewer and Christianna his wife John Brewer and Lavina his wife James Brewer, Sarah Brewer, Nancy Brewer, Alcy Plowman late Alcy Brewer and William Smith and Polly his wife late Polly Black heirs at law of John Brewer deceased, of the one part all of the county of Scioto except William Smith and Polly his wife who is of the county of Adams all of the state of Ohio, and David Crull Junior of the county of Scioto, and state aforesaid of the other part, Witnesseth that the said Richard Brewer and Christianna his wife, John Brewer and Lavina his wife, James Brewer, Sarah Brewer, Nancy Brewer, Alcy Plowman late Alcy Brewer William Smith and Polly his wife late Polly Black for and in consideration of the sum of two hundred and three dollars current money of the united states of america to us the before mentioned heirs of John Brewer deceased in hand paid the receipt whereof we do hereby acknowledge and forever acquit and discharge the said David Crull Jr. his heirs, Executors and administrators, hath granted, bargained, sold, (assigns) and confirmed and by these presents doth grant, bargain, sell, (assign) and confirm unto the said David Crull Junr. his heirs and assigns forever all our several parts of the undivided tract or parcel of land containing one hundred and one and half acres be this more or less lying and being in the state of ohio and county of Scioto, known by the southwest quarter of section thirty three, range twenty one and Township three. together with all our right, title, interest and claim to the said premise belonging or in any wise appertaining to us to have and to hold the land hereby conveyed unto, the said David Crull Jr. his heirs and assigns forever and we the aforesaid heirs of John Brewer deceased for their heirs, executors and administrators do covenant and agree to and with the said David Crull Jr. his heirs and assigns by these presents that the premise before mentioned now and forever hear after shall remain free from all former sales, bargains, dowers, rights, or title of dower and all other encumbrances whatever and the said premises thereby bargained and sold from all and every other person or persons whatsoever, will warrant and forever defend by these presents.
