According to widespread family legend, "Samuel the First" was Welsh, but this seems unlikely, as the name is thoroughly Anglo-Saxon (meaning roughly, "wife's farm"). The only other connection found thus far is the parish of "Winstead" in the East Riding of Yorkshire. No families named "Winstead" appear in its parish register, however. First documentary record: Samuel was appointed Constable for Matapony by the County Court, May 19, 1697 (Northumberland County Orders, p.770).

Last Will and Testament of Samuel Winstead

In the name of God, Amen. I, Samuel Winstead Sen' , of the Parish of St. Stephens in the county of Northumberland, Planter, being well in health and in body and of sound and perfect memory, thanks be to almighty God, but call into to remembrance the uncertain state of this transitory life and that all flesh must ye call unto death when doth all please God to call. Do make, constitute and ordain and declare this my last will and testament in a manner and for following, Revoking or annulling [annulling] by these presents all and every testament or testaments, will or wills heretofore made by unto or dictored [dictated] either by work or writing and this to be taken only for my last will and testament and none other.

First, I bequeath my soul into the hands of almighty God my maker, hoping to be saved by the meritorious death passion of Jesus Christ, my only savior and redeem, and my body to be buried in Christian Burial at the discretion of my executor, here after and by these presents named, and as for worldly estate which it hath pleased God beyond my desires to bestow, I give, devise and bequeathed in manner and form following.

Item, I give and bequeath unto my granddaughter, Betty Winstead, one good feather bed and boulster and two pillows and a good Rugg and blankets and one cow and calf with all their future increase.

Item, I give unto my grandson, Daniel Winstead, one three years old gelding.

Item, I give unto my grandson, Samuel Winstead, one cow and calf with all their future increase.

Item, I give, devise and bequeath unto my son, Sam'; Winsted Jun' my plantation whereon I now live and all the land thereto belonging and the rest of my estate, all of goods, chattels, cattle horses, mares, moveable and unmovable, to him and his heirs forever and my former devises's.

My 1st will is that anything of all my worldly estate, any not fit to appointment and I do hereby make my aforesaid loving son, Samuel Winstead, my executor of this, my last will and testament, Revoking and hereby ? all other will or wills, testaments or testaments heretofore made by me or caused to be made either by work or writing and confirming this to be my last will and testament and no other.

"My four oldest slaves, Will, Dwinsher, Sarah, and Sone, to be sold and so equally divided amongst my former children that I had by my first wives."

"The rest of my estate to my wife, Winnifret during her natural life and afterward to be equally divided amongst all my children."

"Sameul witnessed wills of George Howell, 27 April 1727 (Record Bk 1726-29, p. 116); Martha Booth, 15 April 1757 (Record Bk #4, p. 61); and William Wildy, 13 April 1759 (Record Bk #5, p. 81) -- all of St. Stephen's Parish. Acted as executor of his father's estate; received the plantation and most of the residue. No other children (i.e., brothers of Samuel) were named in the will.

Know all men by these presents that I, Winefred Winstead of the County of North'd and parish of St. Stephens, do make over my whole Estate of Lando, Negros namely George, Richard, Job, Harry, Sarah, Lucey, Minnay, and Sarah, and all my Stock of Cattle, Hogs, Sheep & Horses that I shall have in possession on the first day of November 1783. To my son, Francis Winstead, to act & manage as my said Son shall think fit for the benefit of my Estate during my natural life, provided that my said Son, Francis Winstead, will maintain my Self and family as far as my Estate will admit of with Frugality, etc., and I do agree that if my Son, Francis Winstead, should make anything more than for my Support above mentioned that he may apply it to his own use, and I, the said, Francis Winstead, for my part do agree to settle of all acct's & discharge for my said Mother, Winefred Winstead, that shall come against her & further I do agree if I, the said Francis Winstead, should not perform the above as far as the Estate will admit of then I do agree that my said mother should take her estate out of my hands & I, the said Winefred, do agree to perform the above under the penalty of two hundred Pounds. Named in the will of grandfather (Samuel the First), probated November 16, 1726 Northumberland County. Was charged with "stealing sheep" from John Blincoe, August 31, 1726 [Order Bak, 1762-66, p.400-1] -- possibly resulting from an argument over land boundaries. Acted as executor of father's will, probated March 14, 1774. Became County Surveyor of the Road, November 9, 1778 (term of office unknown). On Person County tax list, 1794; 450A. + 3 black polls and one stud horse.

Last Will and Testament of Samuel Winstead III

In the name of God, Amen. I, Samuel Winstead of Person County, North Carolina, being very low and weak in body but in perfect mind as usual and calling to mind the certainly of death and uncertainty of life -- make this my last will and Testament (to wit) after all my just debts are paid. It is my will and desire that my wife, Elizabeth Winstead, have during her natural life the use of the land and plantation whereon I now live, also the following negroes --- Jo, Oliver, Hat, Solomon, Isbal, Glascom, and Davenport. Also my stock of all kinds together with all my household and kitchen furniture and plantation tools with all the crops made on my plantation in the year One Thousand Eight Hundred and

Five -- my will is that my negro, Bet, be sold and the money arising from such sale be paid to my wife, Elizabeth Winstead, for her own proper use. I give to my son, Custance [sic]Winstead, a bond now in my possession against Benjamin Vestal, also the land and plantation I now live on and one cubbard. At the death of his mother, Elizabeth Winstead, to him and his heirs forever.

I give to my grandson, Barnet Winstead, son of Charles Winstead, one bed and furniture and his grandmother's death.

Now it is my will that at the death of my wife, Elizabeth Winstead -- all the property I have lent her and not otherwise given away be equally divided between Custance Winstead, Manly Winstead, Susannah Self, Elizabeth Davey, Ailcy Yancy, John Winstead, and Charles Winstead, and if either of them die before their mother, such part as would have fell to them of my Estate -- my will is shall go to the Heirs of any of my children that may die before my wife, Elizabeth Winstead.

I do hereby constitute and appoint Elizabeth Winstead and Custance Winstead Executors of this my Last Will and Testament. In witness whereof I do hereunto set my hand and affix by seal this 17th day of October, 1805.

5. MANDLEY TAYLOR⁴ WINSTEAD (*SAMUEL³, SAMUEL², SAMUEL¹*) was born October 29, 1760 in Northumberland Co. Va., and died December 26, 1846 in Nebo, Hopkins Co. Ky.. He married (1) ??? TAPP. He married (2) ELIZABETH JANE COX May 17, 1809 in Person Co. N.C., daughter of CHAMPION COX and SALLY WINSTEAD. She was born December 27, 1821 in Hopkins Co. Kentucky, and died February 15, 1859 in Hopkins Co. Kentucky.

Notes for MANDLEY TAYLOR WINSTEAD:

... about 1776 moved to Caswell Co, NC, the portion later formed into Person Co, NC. From Caswell Co he was drafted to serve 6 mos under Capt George Moore in Col. James Saunders Reg of the NC militia, fighting the English in the Am Rev. Later was drafted for 3 mos to serve under Capt. James Greenwood. Discharged at South Boston on the Dan River." "In 1818, he moved to Hopkins Co, Ky where he lived until his death...

"Mandley moved from Virginia to Caswell County, North Carolina, c1776. Was drafted and served six months in Capt. George Moore's company, Col. James Saunder's regiment, North Carolina militia, originally as a drummer boy. He later served three months in Capt. James Greenwood's company, Col. Locke's regiment of light horse militia (no dates given). Appears on Person County tax list, 1794: 200 A. + 1 white poll & 3 black polls. He apparently also served in the War of 1812, but no details are known. From "The Winstead Family in America" by Michael Smith

Mandley moved his family to Hopkins County, Kentucky with his son, Charles, in 1818. He was allowed a Revolutionary service pension on application, 13 August 1832, in Hopkins County, Kentucky. Mandley is listed as a taxable in Capt. Morrow's militia district, Person County, 1805. Also listed in Capt. Webb's district, Person County, 1814. William Tapp's will names his son-in-law, Mandley Winstead; probated August court 1818 (Person County Record Bk #5, p. 54). Documents in Mandley's pension file include statement by son, Charles, that his father had become 'insane' (senile?) c 1840.

Will of Mandley Winstead

In the name of God Amen

I Mandley Winstead of Hopkins County and the State of Kentucky being of sound mind and disposing memory but calling to mind that it is appointed once for man to die, do therefore proceed to make this my last Will and Testament in manner and form as followeth, to wit, My body I resign to its mother dust when it may please God to remove my spirit and my soul I bequeath to God who gave it hoping to participate with him in the happiness of Heaven where he dwelleth.

As to my property I make the following disposition,

First I give and bequeath to my beloved wife Amy Winstead all the property of every description which she had in possession at the time I married her consisting of one tract of land in Hopkins County on Bull Creek containing one hundred and seventy acres and one negro man named Bob and one boy named Henry and two feather beds and furniture and one common work horse and one cow and calf also two breeding sows and barrows other articles of less value and may be known by the families as her former property also one full year's provisions for my said wife.

Secondly I give and direct one hundred dollars to be paid out of my estate to each of my son Mandley Winstead's two sons whose names are not known to me.

Thirdly I give and bequeath my lower tract of land attached to the tract of which I now live containing two hundred twenty two and one half acres to my sons Bushard D. Winstead and Charles T. Winstead to be equally divided by a line running east and west. Charles T. Winstead to have the part on which he now lives and Bushard D. Winstead the other part.

Fourthly , I give and bequeath to my two sons William M. Winstead and Pleasant B. Winstead the tract of land on which I now live containing one hundred ninety five acres to be divided between them as they may agree.

Fifthly Now in as much as I give all the land I own to my four sons above named my will and direction is that each of them pay one hundred dollars to the estate to enable me to do equal justice to my other children that get no land.

Sixthly I have heretofore given my son Bushard D. Winstead one negro girl named Parthema worth two hundred dollars I have also given my son Charles T. Winstead one negro boy named Beverly worth three hundred dollars I have also given my Daughter Sally Cox one negro boy named Alfred worth two hundred and fifty dollars I have also given my daughter Elizabeth Weir one hundred and twenty dollars I also have given my daughter Anna Yarbrough one hundred and twenty dollars, I have also given my daughter Jane Cox one hundred and twenty dollars now my will and direction is the price or value fixed upon the three negroes above named and the money above given namd be paid or divided among my first six children, to wit , Elizabeth Weir, Anna Yarbrough, Bushard D. Winstead, Jane Cox, Sally Cox, and Charles T. Winstead so each may have the same amount of the other.

Seventhly I give and bequath to my daughter Elizabeth Weir during her life and at her death the heirs of her body, Bushard D. Winstead, Anna Yarbrough during her life and at her death the heirs of her body, Jane Cox, Sally Cox, and Charles T. Winstead a certain negro man Jack, a negro Woman named Kesiah, a Negro boy named Daniel, and a negro girl namd Eliza to be equally divided among my said children as they may see fit.

Eighthly All my negroes with their increase not here before namd and disposed of I give and bequath to all of my children namely Elizabeth Weir during her life and at her death to her children, Bushard D. Winstead, Anna Yarbrough during her lifetime and at her death to her children, Jane Cox, Sally Cox, Charles T. Winstead, William M. Winstead, Pleasant B. Winstead to be equally divided between them all as they may see fit.

Ninthly I give and bequath all my personal estate consisting of stock, horses, cattle, sheep, hogs, household furniture, farming utensils and all and every species of property not herein before named and disposed of to my eight children above named.

Tenthly I nominate and appoint my son Charles T. Winstead to execute this my last will and Testament acknowledged and signed this 13th day of July eighteen hundred an thirty-three.

Charles was elected to the North Carolina General Assembly as a representative from Person County, 1850 & 1881; in between, he was elected as state senator, 1860, 1864, 1865, & 1868. In 1860, he served as a member of the North Carolina delegation to the National Democratic Party Convention at Baltimore; none of the delegation voted for secession at that time, though the rump convention of southern Democrats later voted overwhelmingly to secede.

During Reconstruction (c1870-77), while residing in Greensboro, Charles served as Collector of Internal Revenue for Person County at a salary of \$1500 per year [U.S. Official register, 1873, p. 83] a valuable political appointment since it required very little actual work. A Republican named John T. Cramer, a native of Ohio, coveted the job and engaged the help of such prominent men as then Congressman James A. Garfield of Ohio, because of his "efforts and services in behalf of the party." Cramer complained that Winstead "was immensely wealthy before his appointment and has never devoted any of his own personal time to the duties of the office. He lives in Person County, where he spends nine-tenths of his time, leaving the management of his office to his brother and other Kin, some of whom are democrats and not in sympathy with the administration, but all very wealthy. The Collectorship is worth about \$3000 per annum [an exaggeration by double the amount!], and to an aged bachelor like Mr. Winstead, comparatively nothing." Cramer, on the other hand, noted that he certainly could use the income and had been zealous on behalf of his party. In a subsequent letter, Cramer increased his attacks, adding that Winstead lived 75 miles away from his district, and claiming that "during that entire period [of seven years] there has been a system of fraud and violation of law in the way of illicit distilling in his District that has been of a most disgraceful and disreputable character an inexcusable dereliction of duty." In June 1877, Charles Winstead was asked by the Republican administration to resign his office, and, as Cramer related in another letter to Garfield, "as soon as Collector Winstead received his notification to resign, he in company with parties interested in his retention, on account of relations occupying subordinate positions [i.e., nepotism], went to Washington to resist a change in the office, but I am informed with ill success, as Mr. Winstead has written back [to say] he will have to vacate his position, sooner or later."

From "Person County Heritage" article by Margie M. Thomas:

Colonel Winstead was a lawyer by trade and quite well-to-do. He would have a very large Christmas party every year and invite all the elite for miles around. If the young ladies had no way to get to the swell affair, he would send his coachman and coach out to pick them up. It is said that the food he had for these parties was "something to behold."

The war came along, and in those days you could hire someone to go and serve in your place if you so desired. The "Colonel" went to a certain man and paid him to go in his place. He promised the man that if he were killed in action, that he (Colonel Winstead) would look after his family for the rest of their lifetime. The man was killed, and the Colonel was as good as his word. He even left money in his will to be used to look after one member of the family still living. (I think the Colonel must have been the "Rhett Butler" of his day.)

Locke's regiment of light horse militia (no dates given). Appears on Person County tax list, 1794: 200 A. + 1 white poll & 3 black polls. Mandley moved his family to Hopkins County, Kentucky with his son, Charles, in 1818. He was allowed a Revolutionary service pension on application, 13 August 1832, in Hopkins County, Kentucky. Mandley is listed as a taxable in Capt. Morrow's militia district, Person County, 1805. Also listed in Capt. Webb's district, Person County, 1814. William Tapp's will names his son-in-law, Mandley Winstead; probated August court 1818 (Person County Record Bk #5, p. 54). Documents in Mandley's pension file include statement by son, Charles, that his father had become 'insane' (senile?) c 1840.

In the name of God Amen

I Mandley Winstead of Hopkins County and the State of Kentucky being of sound mind and disposing memory but calling to mind that it is appointed once for man to die, do therefore proceed to make this my last Will and Testament in manner and form as followeth, to wit, My body I resign to its mother dust when it may please God to remove my spirit and my soul I bequeath to God who gave it hoping to participate with him in the happiness of Heaven where he dwelleth.

As to my property I make the following disposition,

First I give and bequeath to my beloved wife Amy Winstead all the property of every description which she had in possession at the time I married her consisting of one tract of land in Hopkins County on Bull Creek containing one hundred and seventy acres and one negro man named Bob and one boy named Henry and two feather beds and furniture and one common work horse and one cow and calf also two breeding sows and barrows other articles of less value and may be known by the families as her former property also one full year's provisions for my said wife.

Secondly I give and direct one hundred dollars to be paid out of my estate to each of my son Mandley Winstead's two sons whose names are not known to me.

Thirdly I give and bequeath my lower tract of land attached to the tract of which I now live containing two hundred twenty two and one half acres to my sons Bushard D. Winstead and Charles T. Winstead to be equally divided by a line running east and west. Charles T. Winstead to have the part on which he now lives and Bushard D. Winstead the other part.

Fourthly , I give and bequeath to my two sons William M. Winstead and Pleasant B. Winstead the tract of land on which I now live containing one hundred ninety five acres to be divided between them as they may agree.

Fifthly Now in as much as I give all the land I own to my four sons above named my will and direction is that each of them pay one hundred dollars to the estate to enable me to do equal justice to my other children that get no land.

Sixthly I have heretofore given my son Bushard D. Winstead one negro girl named Parthema worth two hundred dollars I have also given my son Charles T. Winstead one negro boy named Beverly worth

three hundred dollars I have also given my Daughter Sally Cox one negro boy named Alfred worth two hundred and fifty dollars I have also given my daughter Elizabeth Weir one hundred and twenty dollars I also have given my daughter Anna Yarbrough one hundred and twenty dollars, I have also given my daughter Jane Cox one hundred and twenty dollars now my will and direction is the price or value fixed upon the three negroes above named and the money above given namd be paid or divided among my first six children, to wit , Elizabeth Weir, Anna Yarbrough, Bushard D. Winstead, Jane Cox, Sally Cox, and Charles T. Winstead so each may have the same amount of the other.

Seventhly I give and bequath to my daughter Elizabeth Weir during her life and at her death the heirs of her body, Bushard D. Winstead, Anna Yarbrough during her life and at her death the heirs of her body, Jane Cox, Sally Cox, and Charles T. Winstead a certain negro man Jack, a negro Woman named Kesiah, a Negro boy named Daniel, and a negro girl namd Eliza to be equally divided among my said children as they may see fit.

Eighthly All my negroes with their increase not here before namd and disposed of I give and bequath to all of my children namely Elizabeth Weir during her life and at her death to her children, Bushard D. Winstead, Anna Yarbrough during her lifetime and at her death to her children, Jane Cox, Sally Cox, Charles T. Winstead, William M. Winstead, Pleasant B. Winstead to be equally divided between them all as they may see fit.

Ninthly I give and bequath all my personal estate consisting of stock, horses, cattle, sheep, hogs, household furniture, farming utensils and all and every species of property not herein before named and disposed of to my eight children above named.

Tenthly I nominate and appoint my son Charles T. Winstead to execute this my last will and Testament acknowledged and signed this 13th day of July eighteen hundred an thirty-three.
