Genealogy Gems: News from the Fort Wayne Library, No. 95, January 31, 2012

[**WHY**, Phillip, are you including these “Office” how-to tips in a genealogy newsletter? I know a lot of you are raising that question every time you open the newsletter. The answer - When I transitioned from Office 2003 direct to 2010 I was lost. I am a pretty smart feller, so I knew that there were other lost souls out there in newsletter land. So, I’m helpin.]

Technology Tip of the Month--The Microsoft Word 2010 Ribbon: Mailings and Review Tabs by Kay Spears.

Let’s look at the Mailings tab first. There are three tools of interest on this tab: Envelopes, Labels and Mail Merge. I will describe the first two here: Envelopes and Labels. Both of these are fairly simple tools.

Envelopes: When the Envelopes dialog box is open, you will notice boxes labeled “Delivery address” and “Return address.” All you need do is enter the correct addresses in each box and print. However, if you are using an envelope with a return address already printed on it, you will want to leave the return address box blank or make sure the “Omit” box is checked. To change the size of the envelope, select “Options.”

Labels: First, open the Labels dialog box, go to “Options,” select the kind of label you will be printing,

and click "OK." The Labels dialog box will return. If you are printing only one label, enter the "Address," then select "Single label" and the appropriate "Row" and "Column" in the "Print" box. If you want to print an entire sheet of labels with the same address, enter the "Address," then select "Full page of the same label" in the "Print" box. If you want to print an entire sheet of labels, each with a different address, click on "New Document." This will open an entire page of blank labels on which you may enter addresses. Or, you may use Mail Merge instead. I will cover mail merges in the next article.

Now, let's look at the Review tab. This is where Microsoft has located the Proofing tools most often used in reviewing documents. Included are Spelling and Grammar, Research, Thesaurus, and Word Count. The Review tab also contains a Tracking tool, which I suggest that you use sparingly. While this tool may help you keep track of changes, sometimes it can create confusion and frustration for the person who will be receiving your document.

It is with great sadness that the Hawkins DNA group #1 reports the death of Hawkins DNA Participant #11301. James Robert Hawkins died 18 December 2011. He was born on 15 February 1918 the sixth child (twelve

total) of Clara B Lewis (1886-1968) and Harry Wilmer Hawkins (1883-1966) in Birmingham, Alabama. An older brother, Clifford Wilmer, died as an infant before age one. James was gravely underweight as a young child. With the constant care of his mother and three older sisters, James grew to adulthood in the Fairview and Glen Iris neighborhoods of Birmingham. James graduated from Ramsey High School and was mechanically inclined. He enlisted as a marine early in WWII serving as a plane mechanic for much of the war, including the Black Sheep Squadron made famous by Pappy Boyington. In the midst of the war in the Pacific, his sweetheart Juanita Edwards traveled to Los Angeles to stay at a "Women's" hotel for one night. The next day the couple was married at City Hall, Los Angeles. Building their home with his own hands in Forestdale (then county), Jimmy and Juanita raised five children who all remain in the Birmingham area: Dr. Don (Kathy) Hawkins, Suzi Hawkins, Becky Hawkins Usher, Paul (Theresa) Hawkins, and John Hawkins. After the war Jim worked for Southern Railroad and then Northern Southern as a fireman and later engineer. He engineered both steam and diesel locomotives. The last steam locomotive moved in Alabama from a train yard to a museum yard, was driven by James Hawkins,

selected for his long time service and knowledge about those trains. His youngest son, John, follows in his father's footsteps at the railroad.

He was preceded in death by his parents, his wife of over fifty years, Juanita Edwards Hawkins (1918-2001), and all five of his brothers and six of his sisters and their spouses (two died as children Clifford (1909-1911) and Marian(1920-1928)), Stanley (Lillian Copeland) Hawkins (1911-1976), Jefferson (Elizabeth Stewart) Hawkins (1922-2008), Donald (Jean

Hamblin) Hawkins (1924-1989), William (Bea McAteer) Hawkins (1929-1979), Dorothy Hawkins (1907-1990), Ruth (Bill) Hawkins Shively (1913-1980), Margie (Summers) Hawkins Needham (1915-1986), Betty (Robert) Hawkins Norton (1927-2007), and Carolyn Hawkins Palmer (1931-2004), all originally of Birmingham.

Our earliest ancestor is William Hawkins of Orange County, VA. Other lines in successive generations are: Jehu Dyer, Burton, Bluford and Joseph Ferguson. As of the date of submission of this article we are unable to link any of the different lines in our group. We also have a new participant with the name of Kirkpatrick that matches us on 37 of 37 markers. In all of the Hawkins groups that participate we probably have more issues than any of them. I have scanned many records trying to link at least one line with no success. Many records still need to be scanned for that magic link. For us DNA testing could be the answer, but we need participants to step up. FT-DNA has run many specials, but participants are not stepping up. Please encourage Hawkins descendants to get tested.

He is the first from Isaac's branch to test. I think that I was a bit surprised that he tested at 13 alleles on Marker 09 (DYS 439). I was rather expecting a 14. We badly need a couple more testing participants to confirm that number.

Page 106 states “The qualified voters for the presidential election of 1800 presented below have been transcribed from the original lists recorded in Halifax Co., VA Deed Book 18 pp. 461-468. Prevailing laws at the time restricted suffrage to white male property owner possessed of 100 acres, unsettled, or twenty-five acres, improved.}

This seems to connect the Hawkins', at least to me. It appears that since son of Zachariah, John, moved to KY from Halifax Co. VA that possibly Zachariah & family may have moved after he & Elizabeth sold their land on Sandy Creek in 1765

GEORGE TAYLOR HAWKINS, 1853 DYER, TN TO 9 JUNE 1897 ZIONHILL CEMETERY, DYER, TN

Based on the 1860 census George Taylor Hawkins was born in 1853. He was the son of Simeon Peter Hawkins and Isabella Taylor Hawkins. He was also my (Dolores's) second great grandfather. He was a farmer, a saddler and a harness maker. He was a Missionary Baptist. He died 9 June 1897. It sounds like it might have been appendicitis or stomach cancer. He married Rachel Francis (sic) Hickman in Crockett County, TN on 21 September 1877. She was the daughter of William Dixon Hickman and his first wife, Rachel Browder. Rachel Browder Hickman died 18 October 1877, not quite a month after her daughter's wedding. Three and one half months later, the widower married his second wife, Rebecca Hardin of Dyer/Crockett counties.

George was 24 when he married but Fannie, as RF Hickman Hawkins was known, was only 16. Whether it was customary for females in rural areas to marry that young or she was escaping a troubled family life, I don't know. I was given a picture of George T. Hawkins and Fannie Hickman Hawkins by a cousin, but I cannot find it. It shows a dark haired man with dark eyes, very nice looking, but he seems dwarfed by his very blonde wife, who has fleshier features. I know she is younger than George Taylor Hawkins but looks somehow older. I would say they are in their 40's, so this was taken before 1897. I was surprised by how blonde Fannie appears in this old timey photo. I have a photo of her father who is quite brunette and in the 1870 census her paternal grandfather, D. D. or Dixon D Hickman, is listed first as white and then a big B was put over the w. Whether this was in error or not, I have no way of knowing.

George Taylor Hawkins and Fannie had five sons; Walter W, Curry Meldrow, Joseph Fletcher (known as Fletcher), Donnie and George James.

George Taylor Hawkins and Fannie Hickman Hawkins' first child was Walter William Hawkins and he was born 7 Aug 1878 in Dyer county, TN, so it wasn't a shotgun wedding. Walter would eventually marry the next door neighbor girl named Lula Harwell. Walter had blue eyes and auburn hair on his WW I registration form. It looks like he and Lula had six children. Walter seems to have been an upstanding citizen. I don't know where the name Walter came from. I don't know of any earlier Walter Hawkins, but William is his maternal grandfather's name.

George Taylor Hawkins and Fannie Hickman Hawkins' second child was Curry Meldrow Hawkins or Charles Curry Hawkins and he seems to have been a different type altogether. For one thing, as he was frequently in trouble, he kept changing his names as well as his children's. He was born 21 June 1880. I obviously never met the man, although he is my great grandfather. If any descendants have any redeeming stories, I'd love to hear them. Otherwise, I'll base my next installment on what my grandfather and father told me about him.

WW I registration shows him as 38 with medium height, auburn hair, blue eyes and a stout build. He is a train conductor/locomotive engineer for the railroad in the 1920 census. He favors his mother in his coloring and body type.

In the picture to the left, both brothers are behind their wives or future wives. Fletcher looks taller but I believe he is two years younger. I do not know what the occasion was. In the picture above, Fletcher and Crickett Hawkins are on the left and Curry and Audie Hawkins are on the right.

Child number three for George Taylor Hawkins and Fannie Hickman Hawkins was Joseph Fletcher Hawkins who was born 18

September 1882 and died 25 March 1986 at age 103. He was married to Crickett Briggs. In the 1900 census she is 15 and living next door to Curry and his wife Audie Horner Hawkins. Fletcher and Crickett were married sometime before 1905 and have five son's: Roy, Lowell, Victor, Follis and Hollis. Fletcher as Joseph Fletcher was known had gray eyes and dark hair according to his WW I registration card.

He looks like a taller version of his father. Fletcher is obviously young in this picture and although he looks like his father, in the picture of George Taylor Hawkins that I remember seeing, George's face was not so long.

George Taylor Hawkins and Fannie Hickman Hawkins' fourth child was Donny Peter Hawkins born Oct 1890 and died at age 11 in 1902. He is buried at Zion Hill Baptist Church. George Taylor Hawkins and Fannie Hickman Hawkins had a fifth and final child named George James Hawkins. I think he was born in 1893. I think he is listed in the 1910 census as James G. Hawkins as a 16 year-old in North Little Rock. This is where his brother, Curry, went after leaving Friendship. George James lived in the 5th ward, Pulaski county. His WW I registration card shows he is tall, stout, with blue eyes and dark brown hair and bad feet. By the 1930 census he is in North Little Rock and has a wife named P. Alice. He is a punch shear operator for the Missouri Pacific RR.

TIMELINE FOR GEORGE TAYLOR HAWKINS:

1860 census, Dyer district 2, under parents S. P. and I. Hawkins. He is shown as seven with siblings. His father is a farmer with value of real estate of \$1100 and value of personal estate of \$655. They are family #74.

In the 1880 census George Taylor Hawkins is living with his wife and one year old son, Walter W. He has a broken shoulder. According to a note I have from a Kevin Campbell his shoulder had been broken by a runaway mule and was never set by a doctor. It left him deformed. In that same census he is living next door to a J. G. Brahars and a Harwell family. They are family #175 Crockett, Friendship.

1890 census missing.

9 June 1897 died.

Rev. William Hawkins mar. first Cassandra Hawkins and Mary Amos was his other wife. Some of their fourteen children were: Elizabeth, Mary, Jane, John, Joshua and Idney. Another report says he had 3 wives and 13 children.

William mar. Delila Martin dau. of George Martin on Dec. 8, 1774. They were in Amelia CO., VA.

William Hawkins was in the Isle of Wight CO., VA in 1739.

William Hawkins son of John and Susanna received in 1715, 50 acres from his father. They lived in Northampton or Accomack CO. in VA. In 1729, WM. sold his land to ---Harmonson. In 1730 he was living in Pontico, N C.

John Sebree Hawkins mar. Mary Gaines a widow in Jan. 1773 in Orange CO.,VA. This John is usually called Jehu. John Hawkins advertised in the Virginia Gazette April 6, 1769 the following: **"As** I shall have the most pressing Call for Money, at the Meeting of the Merchants this Month and June next, I hereby inform all Persons that are indebted to me for Negroes, as well as those that I have sold on Commission as on my Account, that Suits will be commenced, without respect of Persons, immediately after the Oyer Court in June next. I shall take no Paper Money in Payments, but on Condition that it passes at the Treasury:'

JOHN HAWKINS

John Hawkins was the guardian of James Gaines, orphan of William Gaines. Feb. 22, 1781. His wife was Mary Gaines, the widow of William.

John Hawkins was b. March 10, 1717 in York Co., VA in Charles Parish.

John Hawkins was the great grandfather of Sarah Faulkner. He died before 1740, leaving a will in Prince William CO.,VA. His wife was Mary and the I.A.G Compendium information on him shows that he was one of the members of the Hawkins Family of the English Navy.

John Hawkins and wife Mary sold 150 acres and a plantation in South Lancaster, N.C. to George Slade in 1704. He was an heir of Thomas and Elizabeth Blount Hawkins.

John Hawkins will of Feb. 8, 1716/7 and probated April 10, 1717 ,names wife Mary and daughter Joyce Hartshorne, . whose son Thomas was also named. They lived in North Carolina. Another source gives the same date but calls his widow Sarah. Joyce Hartshorne was the extr. Children were Joshua, James and Ann. Thomas son of Joyce Hartshorne.

Elisha Hawkins this day produced his declaration in order to obtain the benefit of the act of Congress passed 7th day of June 1832 and the said Court do hereby declare their opinion that the above named applicant was a revolutionary Soldier & Served as he states.

1. Alexander H. Rennick, Clerk of the County Court for Franklin County in the State of Kentucky do hereby Certify that the foregoing contains the original proceedings in the matter of the application of Elisha Hawkins for a pension and I do further certify that Henry Wingate Esqr. who hath his name to the certificate purporting to have qualified Jehudia Hawkins proving the Service of said Elisha Hawkins Senr. and which is hereto attached was at the time of doing the same Justice of the Peace in and for the County and State aforesaid duly commissioned & qualified and by law autho zed to administer oaths

In testimony whereof I have hereto set my name as Clerk as aforesaid and affixed the Seal of Said County this 19th day of October 1832.

WILL OF ELISHA HAWKINS

I, Elisha Hawkins, being of the County of Franklin and State of Kentucky, being at this time of perfect mind and memory, but calling to mind the mortality of all living, do hereby ordain and establish this instrument of writing as my last will and testament.

In the first place, I commend my soul into the hand of Almighty God, and my body to be decently buried by the executors to be hereinafter names.

2. It is my will that the plantation and tract of land on which I now live, as well as all and any other of my real estate, as well as all my slaves and their increase also, all my personal estate of every kind, including money I note and due me, shall belong to William Hawkins (black head) who I raised, and his heirs fore er, and all the property I received, by my present wife at the time I married her shall return to her again.

3rd I Hereby appoint the said WilliamHawkins the executor of this, my last will and testament, revoking all formerwills, witness my hand and seal this 2nd day of November 1824.

Personally appeared before me Henry Wingate a Justice of the peace for said County, Jehudiah Hawkins, aged from appearance Seventy-five or six years, who being by me solemly charged and sworn in due form of law to testify the truth touching the Revolutionary Services of Elisha Hawkins, Senr. deposeseth & says that he was 76 years of age on the 25th day of August last past- That he is well acquainted with the Said Elisha Hawkins Senr. now a resident of Franklin County, Kentucky, and that he knew him in Orange County in the state of Virginia in the year 1776 when he enlisted as a regular Soldier under Capt. Francis Taylor and marched under him to Williamsburg, Virginia where a number of troops lay all that summer, and on the next winter they were summoned to the north and the said Elisha Hawkins Senr. returned home in April 1778 having remained in the service under said enlistment two years.

This deponent further states that he always understood and so believes the fact to be that the said Elisha Hawkins Senr. served several tours of Militia duty in the war of the Revolution, but knows nothing of said services of his own knowledge.

Jehudiah X Hawkins

State of Kentucky Franklin County

on the 20th day of August 1832, personally appeared in open Court before the Franklin County Court now setting Elisha Hawkins a resident of Franklin Co. and state aforesaid aged 77 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

I enlisted in Orange county Virginia under Capt. Francis Taylor, 1st Lieutenant William Taylor, 2nd Lieutenant Benjamin Porter, Ensign Francis Coward. I enlisted on the 2nd day of March 1776 according to the best of my recollection and served two years under the same officers and was then discharged at Valley Forge. I belonged to the second Virginia Continental Regiment. I had at one time a regular discharge but, now have nothing to show the same having been lost, nor have I any documentary evidence to show the fact of my service. And I know of but one person now living by whom I can prove my service a Mr. Jehu Hawkins I was once on a furlough to my relation being sick & permitted to return home & he went back to the army with me on private business. I never was in any regular engagement but in several skirmishes. I have been living in Kentucky about thirty six year and the last thirty in the County of Franklin. I hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the pension roll of the agency of any State.

Sworn to: Elisha Hawkins

We William Hickman Jr & John Brown Ministers of the Gospel belonging to the Baptist denomination of the County of Franklin in the State aforesaid do certify, that we are well acquainted with Elisha Hawkins who has subscribed & sworn to the above declaration, that we believe him to be Seventy Seven years of age, that he is reputed & believed in the neighborhood where he resides to have been a soldier of the revolution & that we concur to that opinion.

Sworn to and subscribed this 12th day of September 1832.

REBECCA EDWARDS, daughter of Uriah Edwards, Sr. and Mildred Head, born 21/28 May 1762 in Spotsylvania County, Crown Colony of Virginia, North America, she died 27 July 1840 in Franklin County, Kentucky, her place of burial is unknown. She married in August 1778, by Parson James [W]arye, Jr. at St. John's Episcopal Church, Berkeley Parish (vicinity the present town of Lewiston, Virginia), Spotsylvania County, Crown Colony of Virginia, North America, Mr. REUBEN HAWKINS, his date of birth is unknown, he died in August 1812 in Orange County, Virginia, his place of burial unknown. He was the son of William Hawkins and Elizabeth Wall. They were the parents of twelve children:

Elizabeth Hawkins - William Benton Hawkins born 26 February 1781 probably in Orange County, Virginia - Elisha Hawkins - Roddy Hawkins - Arculus Hawkins - Reuben Hawkins, Jr. - Lucy Hawkins - Moses Hawkins - Uriah E. Hawkins - Milly Hawkins - Benjamin S. Hawkins - Sally Hawkins.

Her husband, Reuben Hawkins died in Orange County, Virginia intestate, however, the following inventory of his personal property was found.
