FINAL DECREE OF DIVORCE

BE IT REMEMBERED That on this day this cause came on for final hearing upon the Bill of Complaint taken as confessed by the defendant, the testimony offered before the Special Master in Chancery, reduced to writing and filed herein, together with the findings of said Master, and upon all other matters and things of record and on file in this cause, and the Court being fully advised in the premises, DOETH ORDER AND ADJUDGE:

1. That this Court has jurisdiction of the parties to and the subject matter of this cause.
2. That the equities of this cause are with the plaintiff and that he is entitled to the relief prayed for in his Bill of Complaint.
3. That the plaintiff for more than ninety days next preceding the date of the filing of his Bill of Complaint has been a bona fide resident of the State of Florida.
4. That on or about the 10th day of January, 1945, plaintiff and the defendant were married, and that plaintiff is entitled to a divorce from the defendant because the defendant has been guilty of habitual indulgence in

violent and ungovernable temper and also because of the extreme cruelty by the defendant, to plaintiff.

IT IS THEREUPON ORDERED, ADJUDGED AND DECREED:

1. That the bonds of matrimony existing between the plaintiff and the defendant be and the same are hereby dissolved, and the plaintiff, George T. Sage, be and he is hereby granted an absolute divorce from the defendant, Susan Hough Sage.

2. The plaintiff has been a resident of the State of Florida approximately 21 years prior to the filing of the bill of complaint.


3. The parties to this suit were married January 10, 1945, separated February 1945, and have lived separate and apart since that time.
