I, BELDEN OMER WHITTED, of Ash Fork, Yavapai County, Arizona, being of sound and disposing mind and well realizing the objects of my bounty, to hereby make, publish and declare this to be my Last Will and Testament and I hereby revoke all former Wills made by me.

ARTICLE I

All of my estate, both real and personal, which I may own, possess or be seized of at the time of my death and wherever the same may be situated, I hereby devise to my wife, PATRICIA WHITTED, if she survives me. If my said wife does not survive me, I devise the same to my adopted daughter, REBECCA LYNN WHITTED, provided however, should REBECCA LYNN WHITTED predecease me survived by a child or children who survive me, I direct that such grandchild or grandchildren of mine shall divide her share in equal parts, share and share alike. If REBECCA LYNN WHITTED is not survived by a child or children, I devise my estate to the E.M.T.'s in Ash Fork, Arizona, whoever they may be at the time, for equipment and expenses.

ARTICLE II

I nominate and appoint my wife, PATRICIA WHITTED, to be the Personal Representative of this my Last Will and Testament and of my estate. If my said wife predeceases me, or is unable or unwilling to accept such appointment, or having undertaken her duties is unable or unwilling to continue to serve, then I nominate and appoint EDIE M. CLINE to be the Personal Representative of this my Last Will and Testament and of my estate. I direct that any Personal Representative nominated by me be exempted from the requirement of furnishing any bond.

ARTICLE III

If my wife, PATRICIA WHITTED, predeceases me and I am survived by a minor child or children, I nominate EDIE M. CLINE to be the Guardian of the person and trustee of the estate of such minor child or children. If EDIE M. CLINE predeceases me, or is unable or unwilling to accept such appointment, or having undertaken her duties is unable or unwilling to continue to serve, then I nominate and appoint BARBARA WILLIAMS to be the Guardian of the person and trustee of the estate of such minor child or children. I direct that any Guardian or Trustee nominated by me be exempted from the requirement of furnishing any bond.

ARTICLE IV

Without undertaking to distinguish between the duties and powers of my Personal Representative and my Trustee, by way of illustration and not of limitation of its powers, I hereby authorize my Personal Representative and my Trustee as follows:

a. I authorize and empower my Personal Representative without license of Court to sell, convey, mortgage, invest, re-invest, exchange, manage, control or otherwise deal with any and all property, real or personal, comprising my estate, and no purchaser need look for the application of the purchase money.

b. In my Trustee's discretion to retain said minor's share, to manage, to invest the same and apply the net income therefrom or such portion thereof and such portion and principal as the Trustee may deem necessary for the proper education, support and general welfare of such minor child until said minor reaches the age of eighteen (18) years, at which time, I direct the Trustee to transfer or pay to such minor the accumulated income, if any, and the balance of the principal.

ARTICLE V

Neither principal nor income of the trust herein established shall be pledged, transferred, sold, anticipated nor encumbered by any beneficiary herein named, nor be, in any manner, liable, while in the possession of the trustee, for any debt, contract or obligation, nor for any claim, voluntarily

or involuntarily created, either legal or equitable, against any beneficiary, including claims for alimony or support of any spouse of such beneficiary.

IN WITNESS WHEREOF, I have hereunto set my signature to this my Last Will and Testament, consisting of this and two (2) preceding typewritten pages, which have been signed by me, in the presence of two (2) persons who have, at request and in my presence and in the presence of each other, acted as witnesses this 11th day of May, 1984, at Williams, Arizona.

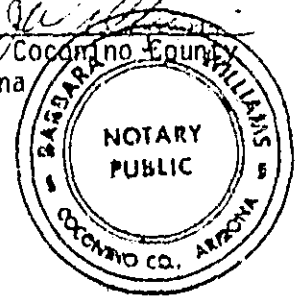
