Now, if the said parties aforesaid do and hence, have a lawful right to the same, and if they shall satisfy every other law and statute with the same, and shall within sixty days from the date hereof, return the said license to the office of the Clerk of the County Court of said County, duly received and officially signed by some one authorized by law to collect the fee of said license, and the obligation shall be void, and otherwise to remain in full force and virtue.
