## Bad Tories

In the PA Archives (s41, v14), beginning at page 639, there is a report on the Meeting of the Standing Committee held at Easton, PA on February 15, 1777. At this meeting, the Committee considered charges against Jacob Wertman and others — “For certain treasonable practices committed by them against the said State, as well in signing certain papers to the prejudice of the American Cause, as in their Conversation, etc.”

The report refers to a paper the defendants signed but does not reproduce it. I was able to get a copy of the original document (in German) and a partial translation from the Pennsylvania State Archives:

“Be it known to all it may concern that we inhabitants of Lynn Township in Northampton County, the province of Pennsylvania, have united ourselves on account of the great uneasiness because we are not willing to fight in such manner, for which reason we are in great danger with our goods and property and are not secure from having our person and goods forcibly seized by a party. We are therefore determined to defend ourselves, if attacked, on this condition that if they leave us in peace we will likewise remain peaceable and quiet. We therefore bind ourselves to each other in the sum of fifty pounds lawful money of Pennsylvania. If any one shall break the above mentioned agreement he or they shall pay the above mentioned sum of fifty pounds without further delay. If any company or particular person shall be attacked.... (incomplete)

Signed by 80 individuals including Jacob Wirtman, Philip Wirtman, Martin Wirtman, and Michael Wirtman.

The arrests were made by Colonel Henry Geiger who reported to the Council of Safety on December 17, 1776, as follows:

“Most Honourable Gentlemen

I beg leave to approach your lordships with this fue lines and let you know in what condition our neighbourhood is now concerning their many Tories which we have now they go now by hundred in one township together I was obliged to call several true Associators together for to attack them Tories. And I had not more then fourty men together and I march on against them before day [...?]. They was together in one house and they run off except three men we took prisoner and one other we took out his own house in the same night. But they say they will reinforce themselves and go against our true Association then many of them Tories has signed the Articles of Association but they changed their mind and being bad Tories then they bound themselves each one to the other for the full sum of fifty pounds for to go against us. Therefore, I beg the favour of your Lordships that you will send me your advice what I shall with this bad Tories then. We live in a very dangerous place and I have a ...[?] trouble in my District then I have ten townships for ...[?] through when I will have some men for marching. and if ...[?] your Lordship will allow me some pay for my trouble and some encouragement for the said men which I has with me to attack the said Tories - - God Blesseth you all and preserveth you in good health.

And I am with great regard and esteem your most humble servant

Henry Geiger Colonel  
Heidelberg Township  
in Northampton County  
The 23rd day of December 1776"

There is a chapter devoted to Colonel Geiger in *Sweet Land of Liberty, the Ordeal of the American Revolution in Northampton County, PA* by Francis S. Fox (Pennsylvania State Univ. Press, University Park, PA). The book can be obtained via *Amazon.com* and I found it very interesting. Fox notes that Colonel Geiger was very unhappy that the “bad Tories” were released. He was more unhappy a few weeks later when he was deselected as commander of the Second Battalion. In the interim, the Tories had been forced to join the militia and Colonel Geiger complained that he had

been voted out by the very people he had been concerned about. Author Fox, however, attributes it to other factors.

All Tories, or anyone who did not fully support the revolution, were bad Tories to Geiger. His letter indicates they had signed the Articles of Association and then reneged but that may just have been his support for having taken the action. The point of Fox's book is that although there were many people in Northampton County who were opposed to the war, or at least on the fence, the people in charge of the County were radicals who attempted to force everyone to support the cause of the revolution. Although much of it was directed toward the religious groups, he cites other examples of just going after people who didn't toe the line.

I think Geiger acted within what he believed his job to be. According to Fox, arrests were made by another officer at a second residence. The individuals arrested were taken to Reading, then marched to Easton where they were fined and paroled. Jacob Wertman paid 1200 pounds.

Why only Jacob is mentioned in the published PA Archives is not known. Perhaps he was the only one arrested and fined. When the issue was forced, all took the Oath and served in the militia. All but GPII, that is! He fled and lost his land.

## ***The Oath of Allegiance***

Fox has a chapter in which he describes how the Moravians refused to take the Oath. They hung in there, and in December 1778, the Act was changed so that the only penalty for not taking the oath was a prohibition on being elected to or holding any place of trust under Pennsylvania government and from serving on juries. Previously, the penalties were loss of citizenship, confiscation and sale of personal property and land, and banishment from the commonwealth. The original act required that every male over 18 had to take the Oath by June 1, 1778. In effect, they had almost a year to sign. In those days, it took a while to get the word out to everyone. Martin took the Oath in 1777, Jacob and Michael on 27 March 1778, Philip on 8 April 1778, Simon on 29 May 1788, and Jacob Jr on 12 April.

## ***More Research is Needed***

Philip Wertman affirmed. ...Some others who affirmed were Daniel Oswalt, whose name followed Jacob Wertman on the agreement, Jacob Oswalt, Thomas Everett, Zacharias Haller, Tobias Stable-

ton, John Probst, and Michael Lieby. In the forward of the report on Oaths, the author says, "The word 'affirmed' following any name indicates that the subscriber belonged to one of those religious sects whose faith precluded them from taking an oath." It could be broader than that, and that men of GPI's age "affirmed." An interesting project would be to get the entire list of 4,000 plus who took the Oath, see which were from Lynn Township, compare their dates for taking the Oath, and try to make some determination regarding those who affirmed.

There is certainly a wealth of information available at the Archives but obtaining copies by mail is almost impossible unless you know exactly what page you want copied. These documents were in Records Group 27 and they sent me all the pages cited by Fox relating to the arrest of Jacob. However, Fox must have had a different numbering system or something, because half the pages didn't contain anything. The only thing to do is to visit Harrisburg and look for ourselves.

We may never know for sure which [George Philip I, II] is which. I am sure there is additional information at Harrisburg that may shed some light. For example, under the Militia Act of March 17, 1777, all men ages 18 to 53 were required to serve in the militia or hire a substitute. Fox reports that a "true and exact list" was compiled. Maybe that list still exists.

Possibly the 1778 change severely reduced the number of people taking the oath. Could it be the reason there is no record of Michael's sons, Jacob and George, taking the oath when they became of age? It appears that Michael became a strong supporter of the revolution. It might be that they all became stronger supporters as the tide began to turn in 1778 and the British started to fall back. It is possible that Michael's sons signed up before they turned 18. Here again, I think there is probably more information in the PA Archives that will help resolve this.

Which Jacob Jr. signed? The Jacob on Lynn tax lists in the 1780s? Or the Jacob who died 1806 in Penns Twp., Northumberland County? (Militia records show Jacob Jr. in two classes; perhaps in the records these two are mixed together.) Or Michael's son Jacob (confirmed 2 April 1779, recorded age 16 — actually just a few months from being 18 on 28 July 1779) whose age could have been adjusted to put off the required military service?

It certainly is interesting!

George Wertman, of Heidelberg Twp. in Berks Co., PA, farmer — signed 4 Sep 1790, witnessed by Jacob Gerhard, Conrad Gilbert and Hans Kurtz. Executors were sons Jacob and John.

George gives to his "first and eldest son John for his first birth right the sum of fifteen pounds in gold or silver money..." and to "my youngest son Jacob who lives with me, my plantation wherein I live which contains one hundred and fifty acres of free deeded land with all my right and title in writing and yet fifty acres of land which adjoins the plantation with a deed poll in writing, and also a piece of woodland of fifty acres more or less lying at the blue mountain in Tulpehoccon Township in Berks county adjoining the land of Nicholas Long and Benjamin Lightfoot also with deed poll in writing... for nine hundred pounds in gold or silver....forty pounds of money the 25th day of May 1793 and forty pounds of money paid the 25th day of May 1794 and every year the said paid and my children shall inherit according to their ages."

John, the eldest son, received the first payment; then a daughter Anna; the third, a son Christian; the fourth, a son Jacob; the fifth, two grandchildren by a deceased daughter Maria; the sixth, a daughter Elizabeth; then beginning again.

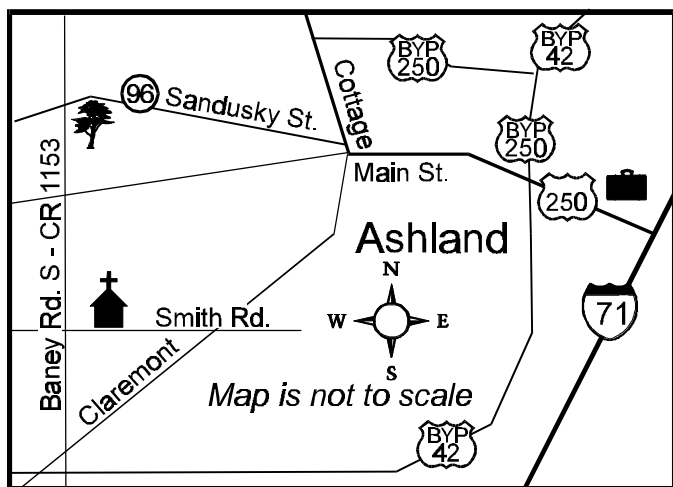

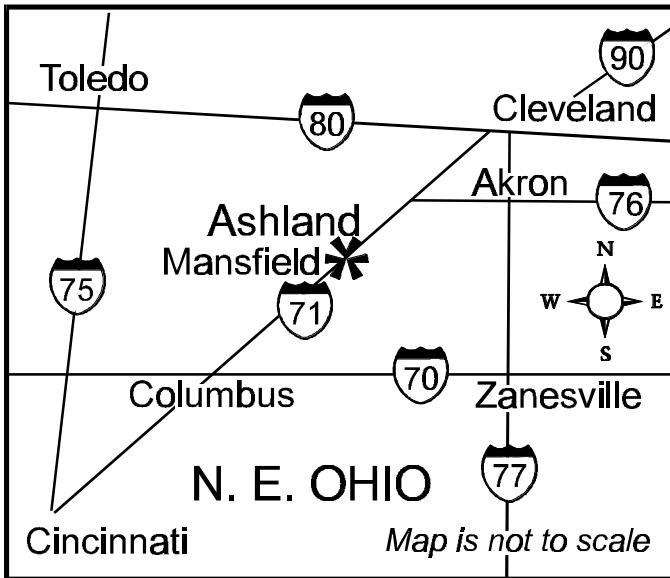

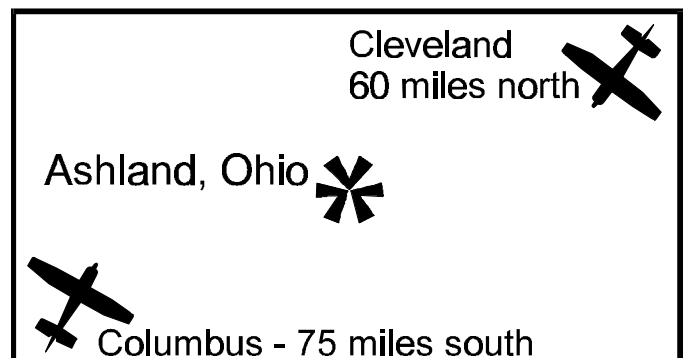
