A Word from the Historian's Corner

Most of you are aware of the fact that Maurice E. Woodworth devoted a good share of his long life to maintaining the Woodworth Genealogy. Indeed, many of you corresponded with him personally. By chance our lives became entwined by our common interest in 1969, and we became close genealogical friends altho we never met face-to-face. To this day our not meeting has been one of my biggest regrets; however, his influence changed my life dramatically. After his passing ca 1978 I reached a "low" as regards genealogy. Two people helped to keep that small flicker of light burning over this difficult period. One was Julian (k/a Woody) Woodworth (WJ-123 442 12) who scoured the New Brunswick, Nova Scotia and northern Maine areas leaving no stone unturned in his effort to find his ancestors and who wrote page after page (in long hand) to me, bouncing ideas off the walls, when he was actually more competent in this particular area than myself!! He alone is responsible for adding much new material to the Woodworth genealogy from the NB, NS and Houlton, ME areas. Those few who he couldn't contact personally, he jotted down their addresses from telephone directories and passed them along to me. In turn, these additional contacts helped to add a good deal more. To this day I feel a special closeness with the Canadian Woodworths, not to mention a deep appreciation for Julian's efforts.

In the past few years, one other person stands out as having been an inspiration to continue. I am deeply indebted to G. Alan Royce (WB-611 line) for his contributions and his letters of encouragement. Most of the "References" listed in the Woodworth Typescript are because of his meticulous way of recording references from other printed material. This has enhanced the Woodworth genealogy, particularly from the first through 7th generations. His ability to analyze difficult genealogical situations has been invaluable to the family. I have called on him more than I should have for his advice, and he has always come to the rescue.

Although I have been active in helping to type and document the Woodworth Family of America typescript since 1969, I am by no means a professional genealogist. My knowledge comes strictly from what has been learned, by correspondence with Maurice E. Woodworth (my mentor), other knowledgeable family members and from the "school of hard knocks." No one person can be singled out for what is now the Woodworth Family Genealogy. It took many years of team effort and much hard work by many dedicated family members too numerous to mention here to get to the point where we are today.

W O O D W O R T H

The following is submitted by G. Alan Royce (WB-611 line) and comes from Ancestral Items of the Woodward Family by Adeline Gross, Piqua, Ohio, 1906 p. 1 and following;

"From an old deed of estate Conveyance found in the archives of the Island Church of Barfleur, Normandy, in 1840 by John Manion, a distinguished notary of Cherbourg, Normandy, we learn that a family of noted "Sea Kings" of Elsinore, Norway (Wasn't Elsinore in Denmark, scene of Shakespears's "Hamlet"? GAR), A.D. 912, named "Vidarvorde" equipped ten ships for the service of Rollo, first Duke of Normandy. For that gallant service to said prince on the Norman coast, "Rurick Vidarvorde", head of said family, was granted the Demesne of Chau, De La Montague, Val de Saar, Normandy, where the family lived in opulence and high respect up to the Norman invasion of England.

".... The name of this ancient Anglo Norman family up to the year 1066 was spelled De Boisgarde, having been translated from the Norse spelling to Norman French For valorous service at the battle of Hastings, two gentlemen at arms, Guilliame and Richard Du Boisgarde were chartered under royal seal of William the Conqueror to manors at Shoevington and Standish, county of Lancaster. In the deed of conveyance, they had their name, Du Boisgarde, Anglicized to Woodward, such being a literal translation. They had the honor of having their names enrolled among those 648 knights whose names were preserved in the tapestry hung by William the Conqueror in Battle Abbey...."

The following is from the genealogical columns of the Boston Evening Transcript, 12 June 1922 (#9563) as submitted by G. Allen Royce to this newsletter.

".... Vedvord (Vid Varde) (Wards of the woods) under the first Duke Rollo, fitted out ten ships at his own expense to be used in the conquest of Bretagne, now part of France. Here the name was changed in due course to De Boisegarde. From France, they migrated to England, where the name was Anglicized to "Woodward." Father Walter, and probably his brother Thomas, came first to America in 1628 and returned to England after a short stay. Walter returned with his family in the ship "Mary and John" ca 1630. Walter Woodward b. Kent, England, married and had children...." (Where the information in the last three sentences came from is not stated, but it is the first - and only - time I have found mention of Walter having a brother Thomas, and that he came from England with his family, instead of marrying here. And again, the story of the "Mary and John" crops up. GAR).

WOODWORTH

Of the four Sons of Walter Woodworth, his eldest son Thomas has the least amount of descendants on record in the typescript with less than 30 pages, total. Benjamin, Walter's third son has the largest number of descendants and they take up in the neighborhood of one-half the pages in the approximate 1,000 page typescript; Joseph, Walter's second son, would place second next to Benjamin for number of descendants; and Isaac, Walter's youngest son would fit in between Thomas and Joseph. Thomas and Isaac are the two sons whose lines need the most work on them, although all lines are incomplete in one way or another.

Below are the write-ups for Walter Woodworth's eldest sons, Thomas and Joseph as I have them recorded. I am always interested in comments, additions, corrections, and new references to list to whatever appears in the newsletters.

WT THOMAS 2 WOODWORTH, son of Walter 1 of Scituate, MA; Born ca 1640, Scituate, MA.

Thomas m., 8 Feb 1666, DEBDRAH DAMON, b. 25 Apr 1645, dau. of John and Katherine (Merritt) Damon.

They resided at Scituate. However, Thomas purchased lands at Little Compton, R.I. as early as 1674 although it is not known if he ever lived there.

On May 20, 1673, his home was burned by Indians who made an incursion into Scituate and committed extensive damage.

In 1690 he was chosen "Clerk of the Market" and held that office for over 20 years; and in 1712, he was appointed "Sealer of Weights and Measurers" which is understood to be another name for his previous office.

His will was dated 13 Feb 1718 and proved 17 Mar 1718/19. His wife Debra was mentioned; his son Hezekiah of Little Compton; John; Ebenezer to have homestead; daus. Deborah Pincen, Catherine Danforth, Mary Vinal, Hannah Jackson, and Jerusha Randall. Children - all b. Scituate, MA

WJ JOSEPH 2 WOODWORTH, son of Walter 1 of Scituate, MA; Born ca 1644, Scituate. Died after 3 Dec 1720, date his will was made.

Joseph m. 6 Jan 1669, Scituate, SARAH STOCKBRIDGE, dau. of John and Elizabeth (Hatch) (Soan) Stockbridge. Sarah bap. 15 Mar 1645. From Thomas Hatch of Barnstable and Some of His Descendants by Charles L. Pack, 1930, p. 42: "Elizabeth Hatch, b. ca 1600, d. in New England between 1647 and 1654. She m/1 in England, Robert Soan of Brasted, Co. Kent, who was living on 23 Mar 1628/9. She m/2 at Scituate, 9 OCT 1643 as his second wife, John Stockbridge of Scituate, Wheelwright. Had one son by first husband and 3 children by second."

Joseph is mentioned in the Scituate Records as a freeman in 1689. He was a shopkeeper at Scituate, however, he purchased lands at Little Compton, R.I. He conducted his "trading post" some 60 rods south of the Stockbridge grist mill. It was stated he often assisted in the milling of the grain since the senior Stockbridge had removed to Boston and left the operation in charge of his son, Charles.

Joseph witnessed a deed of William Tubbs, Sr. on 23 Mar 1671/2.

In the records of the Colony of New Plymouth 7:197, he was one of a jury, 7 Mar 1675 before Governor Josiah Winslow. In the same records, p. 312, in the Oct. court session evidently same Juror Capt. John Williams of Scituate complained against Joseph Woodworth and other claimers pretended proprietors in partnership with the plaintiff in undivided lands in Cohasset, MA. The action was non-suited and 42 sh. allowed the defendants.

Joseph made his Will 3 Dec 1712 naming his son Benjamin as sole executor (See original copy of Will attached) and mentioning his wife Sarah and all the children; she having outlived him. He willed his wife Sarah "the sole use and improvement of the easterly end of my now dwelling house and cellar belonging to it for her comfort and conveniency during the time that she shall remain my widow and also five pounds per annum to be yearly paid to her after my decease...."; He bequeath to his son Joseph "all that my estate both of housing and land and meadows lying and being in Little Compton which he the said Joseph is now in the possession and improvement of...."; He bequeath to his son Benjamin "all that my estate of housing and lands whereon I now dwell said lands containing fifty acres being more or less bounded easterly partly to the lands of Thomas Woodworth,...."; To daughters Margaret, Sarah, Elizabeth, Abigail, and Ruth, he bequeath to each "fifty pounds in good and lawful bills of credit of this Province to be paid by my executor hereafter named...." An Inventory was taken 15 April 1718 (See Attached); and on 13 June 1718, Samuel Clapp and Nicholas Wade made an oath that they witnessed the signature of Joseph Woodworth on his Last Will and Testament and that he was of sound mind and memory to the best of their knowledge.

WILL OF JOSEPH WOODWORTH

In the name of God Amen. This Third day of December In the Year of Our Lord One thousand Seven hundred & Twelveth Joseph Woodworth of Scituate in the County of Plymouth in New England his bandman being weak of body but of sound mind and memory praised be God for it, and considering that it is appointed for man Once to dye. Do make and Ordain this my Last Will and Testament. I commend my Soul to God that gave it and my body to decent burial at the discretion of my executor hereafter named: and as touching such worldly Estate wherewith God hath blessed me in this Life. all my Just Debts and funerals Charges being satisfied and paid I give demise and dispose of the same in Manner and form following. *Viz.* Imp^o I give and bequeath to my beloved wife Sarah Woodworth - the Sole use and Improvement of the easterly end of my now dwelling house, and the Cellar belonging to it for her Comfort and Convenience During the time that she shall remain my widow, and also five pounds per annum to be yearly paid to her after my decease by my executor hereafter named, either in money or in other good merchantable tray at money paid. And if my said wife shall marry again then I give unto her the Sum of Ten pounds in money, to be paid by my executor hereafter named, and also five bed and furniture.

I give and bequeath to my son Joseph all that my estate both of housing & Land and meadow lying and being in Little Compton which he the sd. Joseph is now in the possession and Improvement of which said Lands and meadows are particularly bounded as by record may appear reference therunto being had. To have and to hold to him his heirs & assigns forever.


I give and bequeath to my son Benjamin, all that my estate of housing and lands wheron now dwell said Lands containing a fifty Acres be it more or less bounded easterly partly to the Lands of Thomas Woodworth; partly to the meadow southerly to the River westerly to the Land of Thomas Woodworth, northerly to the Common. Also Ten acres of fresh meadow be it more or less bounded easterly to the brush Hill, Northerly to Thomas Woodworths meadow, southerly to the river westerly to the above mentioned Upland. Also a certain piece of Salt Marsh being

graduate of Amherst College and recipient of a Ph.D. from Columbia University in 1912, Mr. Woodward was for many years associated with E. I. duPont de Nemours as a chemist and holds more than 25 patents in the field of azo dyes and pigments. After retiring he became a Registered Representative of a member of the New York Stock Exchange, serving as co-manager and Manager of their branch Office at Salem, NJ, until 1969. A member of our Society since 1975, Mr. Woodward is a member of the Sons of The American Revolution and in 1980 was elected a member of the American Antiquarian Society.

From p. 131. Appendix - Descendants of Robert Woodward:

ROBERT WOODWARD, born at Boston, Mass., about 1657; died at Scituate, Mass., in 1744. He married first in 1685 BETHIA TORREY, b. 19 July 1655, d. 11 Sept 1735, dau. of Lieutenant James Torrey of Scituate. He married second MARY(-----) SOPER, widow of Thomas Soper and mother of his son James's wife.

James "Woodward" was appointed administrator of the estate of Robert Woodard 21 May 1744, showing that Robert lived until that year. On the books of the Second Parish, Scituate, it is recorded 7 June 1730 that "Robert Woodard was admitted into full communion when upwards of 70 years of age."

The first authentic record of Robert Woodward is found in the Scituate vital records where it states that Bethia, dau. of Robert was born 5 Dec 1685 (Vital Records of Scituate, Mass., to the Year 1850, Boston, 1909, 415). In this record he is called "Woodward." For many years it was assumed that Robert was a grandson of the immigrant Walter Woodward of Scituate through his son Benjamin. In 1691 Benjamin Woodward moved to Little Compton and in 1704 to Lebanon. CT, where he d. in 1728. He left a large family and mentions their names in his will but there is no Robert. The second generation of the Walter Woodward family all adopted the spelling "Woodworth." It is possible that Robert was the son of another Benjamin Woodward who may have been a brother of Walter, or that he was a Son of one of Walter's children who died while Robert was very young. There is traditional evidence that his father's name was Benjamin. The first Son was named after Robert's father-in-law, one dau. was named after his mother-in-law and two other children were named after sister-in-laws. It seems likely that the second son, Benjamin was named after Robert's father.

Many authors have tried to place Robert as the son of Nathaniel 2 Woodward (Nathaniel 1) but there seems no evidence to support this theory. Frank Ernest Woodward (#85), author of Woodward articles in the Maine Historical and Genealogical Recorder (see vols. 3,4,7,8,9 (1886-1898)) at first placed Robert as the son of Benjamin, then changed his mind and sought out information linking him to Nathaniel 2 and Nathaniel 1. In Frank Ernest Woodward's obituary in The New England Historical and Genealogical Register (75 1921:243-246) it is stated that "His paternal ancestry has been traced to Robert Woodward of Scituate, Mass., but the proof necessary to carry the line farther back to Nathaniel Woodward, an early settler in Boston, as some have tried to do, seems to be wanting." In his manuscript at the New England Historical Genealogical Society, "Desc. of Robert Woodward of Scituate, MA" (ca 1902) Frank Ernest Woodward concluded that Robert was probably not the son of Benjamin 2 (Walter 1).
